

WAIVER, RELEASE AND ASSUMPTION OF LIABILITY

In consideration of being allowed to utilize the facilities of, and to participate in any way in East Braintree Little League (“Releasees”), related events and activities, including without limitation any training sessions, clinics, practices, travel teams, games or other activities of any description at any location (“EBLL Activities”), the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury and/or illness from the activities involved in the program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist;
2. The risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies does exist, and it is impossible to eliminate the risk that I could be exposed to and/or become infected through contact with or close proximity with an individual with a communicable disease;
3. COVID-19: The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an individual can be infected with COVID-19 without their knowledge and be asymptomatic. EBLLE will have preventative measures in place to reduce the spread of COVID-19. However, EBLLE cannot guarantee that I or anyone else will not become infected with COVID-19, including my spouse, guests, other children, or relatives. Participation in EBLLE Activities, could increase the risk of contracting COVID-19.
4. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume all full responsibility for my own participation and, if applicable, the participation of any individual to whom I am parent or guardian. I specifically acknowledge the contagious nature of COVID-19 and similar contagions, voluntarily assume the risks that I may be exposed to or infected by participating in EBLLE Activities, and understand that such exposure or infection may result in personal injury, illness, permanent disability, and death.
5. I willingly agree to comply with not only the stated and customary terms and conditions for participation in EBLLE Activities, but also with any suggested or mandatory best practices, guidelines and other measures that may be issued by government authorities and/or EBLLE. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself and those for whom I am responsible from participation and bring such to the attention of EBLLE immediately; and
6. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS EBLLE, its officers, coaches, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of the premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, loss or damage to person or

property, including all liabilities, actions, damages, costs or expenses of any kind, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

7. I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT AND ACKNOWLEDGE BY SIGNING BELOW THAT I FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT ON MY OWN BEHALF OR ON BEHALF OF THE YOUTH PARTICIPANT TO WHOM I AM PARENT OR GUARDIAN, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

ACKNOWLEDGEMENT BY ADULT PARTICIPANT: By acknowledging and signing below, and/or by indicating my assent by registering my child to participate in EBLI Activities, I agree and verify the following: 1) I understand, consent and agree to assume the risks of participation in these programs; and 2) that I specifically agree to the release as provided herein of all the Releasees, and, for myself, my heirs, assigns and next of kin, I release and agree to indemnify the Releasees from any and all liabilities incident to my involvement or participation in EBLI EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
